Dear Taxpayer: This form is used by the county assessor to determine the taxable value of your personal property, e.g. vehicles, recreational equipment, livestock, farm machinery, etc. You are required by law to list all personal property belonging to you or under your control in St. Francois County, Missouri, on Jan. 1st. Complete this form, sign and return it by **March 1st** to avoid penalty.

Late Personal Property Lists—Sec. 137.345 of SB 62

requires the assessor to assess a penalty on anyone who fails to return his personal property tax list by the first day of March.

The penalty, to be placed in the CERF fund, shall be added to the tax bill by the collector, based on the assessed value of the property that was not reported.
